The USPS & Postal Commemorative Society Working Together? Why?


I have always stated "Collect what you want, however you choose". However, I also try to include that caution and knowledge is also needed. One of the sad jobs a dealer must do is advice a person who inherited philatelic material. A common example --- are accumulations of First Day Covers produced by companies like the Postal Commemorative Society (PCS) – which are worth very little in comparison to original cost.

When going through an old cover lot I came across the envelope shown in **figure B1**. It contains an addressed



FDC of a strip of 3 Scott 1851, showing Henry Knox. I think I remember the USPS sending serviced FDCs undercover, but thought that was to deliver the cover unaddressed, for an additional fee. So, why the addressed item?

Upon opening the envelope I discovered it was full of advertising material **figure B2** from the PCS touting a Disney Stamp Folio full of "philatelic gems" that are available only on a strict "first come, - first served" basis. The cost, as shown in **figure B3**, is only \$37.25!

The bloom is long gone from the Disney related stamps from the 1980s and most issues are still available at a lower cost. I guess I have to admit being naive in not realizing the USPS was in partnership with PCS.

The name currently in use is PCS Stamps & Coins and if you look at the website you can take advantage of the offer of 200 Historic Stamps of America. They are available for the low price of \$21.95 per set of 5. That is a total of \$878.00 for 200 cheap modern 20th century items found in

discount postage bins. There is no extra charge for the 2 wooden chests to store them.

To be sure, there is nothing illegal about this offer. If it gives a collector pleasure, then go for it – you just need to proceed with care when making decisions. PCS does certify that material sold is authentic. **Figure B4** is a certificate for a U.S. Susan B. Anthony Dollar Coin that was sold contained in a FDC. I can't show you the cover as I tore it open to use the coin to pay a toll.
